Mr. Cheng served as general manager of the group clients department (banking business department) of the China Construction Bank from March 2011 to July 2014, and concurrently served as director of CCB International (Holdings) Limited from September 2010 to October 2015. Mr. Cheng served as deputy general manager of the group clients department (banking business department) of the China Construction Bank from May 2005 to March 2011. Mr. Cheng served as deputy general manager of the banking business department of the China Construction Bank from September 2001 to May 2005. From February 1995 to September 2001, Mr. Cheng Yuanguo successively served as deputy manager of the banking business and finance and accounting department, deputy manager of the treasury department, manager of the finance and accounting department, manager of the planning and finance department as well as other positions of the China Construction Bank. Mr. Cheng is a senior accountant. He graduated from China Northeast University of Finance and Economics with a bachelor's degree in infrastructure finance and credit in 1986.

Mr. Wang Yi, aged 55, is of Chinese nationality. Mr. Wang has served as general manager of the housing finance and personal credit department of the China Construction Bank since November 2013. Mr. Wang served as deputy general manager of the personal savings and investment department of the China Construction Bank (equivalent to department general manager of the head office of the Bank) from November 2009 to November 2013. Mr. Wang served as deputy general manager of the personal savings and investment department of the China Construction Bank from December 2008 to November 2009. Mr. Wang served as deputy general manager of the personal finance department of the China Construction Bank from June 2005 to December 2008. Mr. Wang served as assistant general manager of the personal banking business department of the China Construction Bank from July 2001 to June 2005. From January 1992 to July 2001, Mr. Wang successively served as deputy division-chief of the computer management division, division-chief of the retail business division and division-chief of the electronic banking department of Qingdao Branch of the China Construction Bank as well as other positions. Mr. Wang is a senior engineer. He graduated from Shandong University with a bachelor's degree in computer mathematics in 1984, and obtained a master's degree of business administration for senior management in 2010.

None of the aforementioned employee representative supervisors held any directorship in other listed companies in the last three years, or hold any positions in any members of the group. There is no other issue that shall be brought to the attention of the shareholders of the Bank.

Due to job arrangements, Mr. Li Xiukun, Mr. Jin Yanmin and Mr. Li Zhenyu have tendered their resignations as employee representative supervisors of the Bank on 17 May 2018, and their resignations become effective from 17 May 2018. Mr. Li Xiukun, Mr. Jin Yanmin and Mr. Li Zhenyu have confirmed that they have no disagreement with the board of supervisors of the Bank and there is no other matter that needs to be brought to the attention of the shareholders of the Bank.

The board of supervisors is extending welcome to Mr. Lu Kegui, Mr. Cheng Yuanguo and Mr. Wang Yi for joining the board of supervisors of the Bank and would also like to express its sincere gratitude to Mr. Li Xiukun, Mr. Jin Yanmin and Mr. Li Zhenyu for their contributions to the Bank during their terms of offices with the Bank.
